



### *What is a network?*

A network is simply two or more computers linked together. It allows users to share not only data files and software applications, but also hardware like printers and other computer resources such as fax.


Most networks link computers within a limited area within a department, an office, or a building. These are called Local Area Networks, or LANs. But networks can link computers across the world, so you can share information with someone on the other side of the world as easily as sharing with a person at the next desk.

When networks are linked together in this way, they are called Wide Area Networks, or WANs.

Networks increase productivity by allowing workers to share information easily without printing, copying, telephoning, or posting. They also have money by sharing peripherals such as printers.

***Network configurations***

A network is a group of devices (PCs, printers, etc.) or nodes connected by communications circuits so that users can share data, programs and hardware resources. A network has two main elements: the physical structure that links the equipment and the software that allows communication.

The physical distribution of nodes and their circuits is known as network ‘topology’ or ‘architecture’. The software consists of the protocols, i.e. the rules which determine the formats by which information may be exchanged between different systems. We could say that cables and transceivers (the architecture) allow computers to ‘hear’ one another, while the software is the ‘language’ that they use to ‘talk’ to one another over the network.

As regards the cables, they consist essentially of the transceiver – the hardware that sends and receives network signals. At present the most widely used transceivers are Token Ring, Ethernet and LocalTalk. Token Ring is the most common method of connecting PCs and IBM mainframes. Most Token Ring adapters transmit data at a speed of 16

megabits per second. With Ethernet, data is transmitted at 100 Mbits/sec. Ethernet provides a very robust, trouble-free architecture with good levels of performance. In this regard, Ethernet is the best solution for first and intensive activity.

LocalTalk transceivers are the cheapest of all because they are directly included in each Macintosh. However, they're a bit slow, which is why most Macs come with built-in Ethernet.

As for protocols, these are rules which describe things like transmission speed and physical interfaces. The Token Ring protocol avoids the possibility of collisions. To transmit data, a workstation needs a token, and as there is only one token per network, holding the token guarantees sole use of the network. With Ethernet there are other options, of which TCP/IP (Transmission Control Protocol/Internet Protocol) is perhaps the most useful since it allows different operating systems to communicate with each other. With regard to LocalTalk networks, they use AppleTalk protocols. The Macintosh operating system includes the AppleTalk manager and a set of drivers that let programs on different Macs exchange information.

LANs can be interconnected by gateways. These devices help manage communications and control traffic on large networks. They change the data to make it compatible with the protocols of different networks.


For long-distance or worldwide communications, computers and LANs are usually connected into a wide area network (WAN) to form a single, integrated network. Two good examples of wide area networks are Internet and Arpanet. They transfer data and e-mail for university researchers and academics, commercial groups, military installations and ordinary people.

Networks can be linked together by either telephone lines or fibre-optic cables. For example, ISDN (integrated services digital network) is an international standard for transmitting digital text, sound, voice and video data over telephone lines. On the other hand, FDDI (fibre distributed data interface) is an optical-fibre network. This new standard transmits data at great speed – 100 megabits per second.

Modern telecommunications use fibre-optic cables because data can be transmitted at a very high speed through the extremely wide bandwidth of glass fibres. The fibre system operates by transmitting light pulses at high frequencies along the glass fibre. This offers considerable advantages (i) the cables require little physical space; (ii) they are safe because they don't carry electricity; (iii) they avoid electromagnetic interference.

Networks on different continents can also be connected via satellite. Computers are connected by a modem either to ordinary telephone wires or fibre-optic cables, which are linked to a dish aerial. This aerial has a large concave reflector for the reception and sending of signals. Then, when signals are received by the satellite, they are amplified and sent on to workstations in another part of the world.

## INTERESTING FACTS

Networks connect computers together, helping them share data or other resources. The computers can be linked to each other, and to other devices, such as printers. This can be done either by wires or fibers – forming a wired network – or wirelessly, using radio signals. Local area networks (LANs), which can be wired or wireless, cover small areas and are used within schools, offices, and other public places. LANs can be connected to each other over wide area networks (WANs). The number of networked computers and other devices is steadily growing, and so is the amount of data they share with each other. It is our insatiable hunger for bandwidth – the capacity to transfer data – that drives the quest for better technology.

Computers are networked partly so that people can use them as communication devices, sending not only text-based messages to each other, but images, audio files, and videos, too. Networking also allows computers to work together, for instance – by sharing data, software, and processing power, and by accessing other devices, such as projectors and scanners. Networked computers are less likely to lose data, since it can easily be copied between machines.

There are two main ways to connect computers together so that resources such as files and applications can be shared – peer-to-peer and client-server connections. In a peer-to-peer network, each computer shares all or part of its resources, and all the computers on the network have equal importance. Client-server networks have a central computer – the server – that manages resources such as storage space and web access on the network and sends data to other computers – clients.

Most computers come loaded with the software needed to set up a peer-to-peer network. Each computer is known as a peer. These networks are prone to being hacked because the peers only handle their own security and not that of the network. Peer-to-peer networks can also be slow because each peer handles requests from the user as well as from other peers.

In a client-server network, the server controls security and distributes software upgrades across the network, so the users of the client computers do not need to worry about these things. This makes

these networks more secure. Client-server networks are often faster, and it is usually easier to add new computers to them. However, servers can be expensive and complex to maintain.

In many schools and offices, the computers that make up a LAN are connected together by wires. Devices called hubs, switches, or routers connect computers into wired networks. Usually, such wired networks use the Ethernet systems in which packets of data, called frames, are exchanged. Each frame has a data header that identifies its starting point and destination on the network.

In a wireless network, radio waves link computers together. Devices called wireless routers send and receive the radio waves. People often use wireless LANs, or WLANs, in homes and public places, such as cafes, airport lounges, or even parks. Though WLANs are much more convenient than wired networks, they are less reliable and less secure – radio waves can suffer interference from electrical equipment and can be intercepted by anyone with the right software on their wireless laptop. One popular wireless technology is called Wi-Fi – a special wireless communication system that allows devices to connect to each other and provides Internet access.

Some wireless networking systems are designed to work over short distances. TransferJet is one such technology – it makes use of radio waves and has a range of only a couple of inches. Simply touching two TransferJet enabled devices together triggers a transfer of data between them. Each device can identify other device nearby that are enabled and users can set them up to transfer only to and from selected devices. For example, placing this digital camera on top of this media storage device transfers the contents of the camera to the device at a very high speed.

Optical fibres are used in many long distance computer networks. Light travels down the fibres over long distances – this is possible because it travels down the core of the optical fibre by constantly bouncing off the sides of the fibre, using a principle called total internal reflection. Light transmits all kinds of data as short flashes arranged in coded patterns. Undersea bundles of fibres can transfer as much as 100 gigabits of data per second. In many cases optical fibres have replaced metal wires because they are unaffected by electrical interference and the data signals can typically travel 60 miles (100 km) before fading.

Cell phones can share data via Bluetooth. This is another short range wireless networking technology designed to work between devices of different types. Bluetooth technology uses frequency hopping, a system in which the radio frequency used to send data changes rapidly. Frequency-hopping signals are less affected by radio interference and also do not interfere with signals sent by other systems.


We use the **Past simple** for completed actions, especially those which take very **little time**. We use the **Past continuous** to describe actions which happen over a **period of time**.



- **URL:** uniform resource locator, the address of a file on the Internet. A URL looks like this:

  - ✓ ‘**http://**’ means hypertext transfer protocol and tells the program to look for a Web page
  - ✓ ‘**www**’ means World Wide Web
  - ✓ ‘**netscape.com**’ is the domain name and tells people that it is a commercial enterprise
- **Navigation buttons:** buttons on the toolbar which allow you to go back or forward to other Web pages. You can also return to your start-up page or stop the transfer when the circuits are busy
- **Links:** shortcuts (underlined text or images) that, when clicked, take you to other Web pages
- **Security on the Web:** just a few Web sites are secure. When the page is not encrypted, the security lock is open




## INTERESTING FACTS

### 1. Read the text quickly and say what this text is about.

A computer on a network relies on a direct connection to a central server or to other networked computers in order to transfer data. When a connection snaps, communication within the network is affected. In the 1960s, the US government realized that its computer network was vulnerable to attack – a few disconnections could prevent the network from functioning, which could be a serious problem during wartime. The solution to this problem was an internetwork – a network of networks that eventually became known as the Internet. If one connection was broken, data could travel via another route. This internetwork ran according to a set of rules – the same ones that ensure the smooth flow of data on the Internet today.

A computer sends data through the Internet in small bundles, or packets. Each packet has an address showing where it is headed and hops along many Internet servers, down miles of cable, until it reaches its destination. The data packets from one dataset, such as from a photo, do not have to travel the same route, or even arrive in the correct order. Once all the packets arrive at the destination computer, it reassembles them into their original form.

The first system to work like today's Internet was the Advanced Research Project Agency Network (ARPANET). This began in 1969, when four American universities joined their networks, forming the first connection points, or nodes. The network grew steadily, and by 1981, hundreds of nodes had spread across North America and western



Europe, and had even reached as far as Hong Kong and


Australia. In the late 1980s, several similar networks merged with ARPANET to become a network of networks – the Internet was born.

Servers are the information warehouses of the Internet. These specialized computers store data, such as emails and web pages, which can be accessed by other computers and devices, or clients, connected to the Internet. Key servers of the Internet handle so much traffic that they require server farms – thousands of individual servers working together. Servers are usually kept in a secure and separate room. They need a cool environment, since all the computers working together can get very hot.

The Internet employs a range of connection types. Many homes are connected through copper telephone lines or television cables. Cell phones and laptops receive Internet traffic over wireless radio links. Optical fibers carry data along the Internet’s ‘backbones’ – thick cables that connect nodes and even run over the seabed. A single cable carries hundreds of high-speed optical fibers bundled together, each see-through fiber carrying data in the form of flickering laser light.

For the first 20 years of its life, only governments, computer experts, and large organizations used the Internet. In the 1990s, the invention of the World Wide Web made the Internet useful for ordinary people. At first, connection speeds were slow. In the early and mid-1990s, only a few kilobits of data could be transferred in a billion

second, making users wait minutes for a large picture to download. By 1995, the Internet had 16 million users – 0.3 percent of the world’s population. As web technologies improved, more people got connected. By early 2011, about 2 billion people were using the Internet.




To many people, the Internet and the World Wide Web (WWW) are the same thing. However, the Internet is the physical network that spans the globe—including the actual cables and computers, and the set of rules that allows data to flow seamlessly. One of the first applications of the Internet was the Bulletin Board System that began in the 1970s, letting users leave messages for each other on public computers, and eventually gave rise to chatrooms. Another was the file transfer protocol (FTP) system for exchanging large files. And of course, the Internet now carries millions of emails every day. Most people connect to the Internet to access the web, an ever-growing collection of interconnected pages, carrying a mix of text, images, and videos.

The British scientist Tim Berners-Lee invented the World Wide Web (WWW) in 1989 as a way of sharing data. His system allowed users to view information on other computers, so a web-enabled computer could access far more data than could be stored in it. Berners-Lee made his invention public, and the web has since changed the world dramatically.

Web traffic surging through the Internet contains fragments of text and images. Each little piece means something to someone, but when put together, it is just a mixture of raw data. *The Listening Post* display at the Science Museum in London, England, pulls random strings of text from chatrooms – places on the web where people can have conversations with one another – and flashes them on a series of screens. The displayed fragments of text are often meaningless, but occasionally something readable appears.

As the number of web pages grew, it became harder to find information of interest. Search engines were developed to pinpoint the right web pages. Early engines used web crawlers – software that reads text on a web page and indexes it, before moving to the next one. Modern search engines, such as Google, still use web crawlers to find pages, and also complex mathematics to highlight the ones that might be most suitable in response to a particular search.



The Internet can be used to share data and resources in many ways. Scientific research programs need powerful computers to perform

complex calculations to help solve problems quickly. The Einstein@Home project uses the Internet to harness the power of computers volunteered by users. When the machines are not being used, Einstein@Home runs a program on them, using their spare capacity to process data collected by astronomers searching for pulsars – small superdense stars that spin around hundreds of times in a second. The program displays a spherical map of the sky with known pulsars shown in magenta. On August 12, 2010, the Einstein@Home system announced a previously unknown pulsar.

Every web page has a unique address called its URL, or uniform resource locator. Web pages are delivered from servers to browsers using a set of rules called the hypertext transfer protocol (http), so a web page's URL always begins with 'http.' The domain name comes next and often starts with 'www' to show human users it is part of the World Wide Web. Many commercial domain names end in 'com.' The domain-name part of the URL tells a computer which server it should contact to access the web page.


Tim Berners-Lee included hyperlinks in his first web pages. These connected certain words and pictures on a page with other pages. Instead of reading from the first page to the last, web users could switch between pages by clicking on the links that interested them. Web programmers encode pages using a language called HTML (hypertext mark-up language), which marks specific words and images that will form hyperlinks.

No one knows how much data is stored on the Internet. There may be around 600 billion web pages – almost 100 for every person alive today. One thing that can be measured is Internet traffic. The speed of data transfer between computers is measured not in bytes but in bits sent in a second. This diagram shows the Internet's bandwidth, or capacity to carry data, between the world's continents, measured in gigabits per second (Gbps).

Users view web pages through applications called browsers. These send out a request for a certain web page into the Internet and display the data that comes back. Tim Berners-Lee programmed the first web browser – known simply as WorldWideWeb – but more advanced browsers, such as Mosaic, Cello, and WebRunner, followed. These

browsers are now defunct. Competition between modern browsers to attract the most number of users is intense.

The web is now part of our daily life. The Internet connects telephones, game consoles, and even refrigerators. Scientists are developing new ways of connecting to the Internet. For instance, the Sixth Sense system allows people to



access the Internet by projecting a keyboard or a screen anywhere. A user can even dial a phone number via a keypad that is projected on the user's hand.



<b><i>Operating systems</i></b>	
<b>MS-DOS</b>	This is the disk operating system developed in 1981 by Microsoft Corp. It is the standard OS for all IBM PC compatibles or clones. In this text-based operating system, you communicate with the computer by typing commands that exist within its library. For example, some basic DOS commands include DIR (shows a list of all the files in a directory), COPY (makes a duplicate of a file), DEL (deletes files).
<b>Windows '95/'98</b>	<b>Windows '95</b> is a bootable operating system in its own right. It has a graphical interface with many Macintosh-like features. It supports multimedia applications and comes with Internet software. The program manager is called Windows Explorer. Buttons and scroll-bars have an attractive, three-dimensional look. With <b>Windows '98</b> , Internet access becomes part of the user interface. Its active desktop lets you find information easily with the same view of content on your PC network or the Web. <b>Windows 2000</b>	This OS is an update to all Windows versions, including Windows NT.
<b>Macintosh (Apple)</b>	Most of the Mac OS code is in the ROM chips. These contain hundred of routines (sequences of instructions) which perform such tasks as starting up the computer transferring data from disks to peripherals and controlling the RAM space. Large parts of the Mac OS are also inside the System file and the Finder, kept in the System folder. The content of the System file is loaded automatically at start-up, and contains information which modifies the routines of the OS in the ROM chips. The Finder displays the Macintosh's desktop and enables the user to work with disks, programs and files. It allows multitasking. It has an Internet set-up assistant, an e-mail program and a Web browser.
<b>OS/2 Warp</b>	This is the PC world's most technically sophisticated operating system. It provides true multitasking, allowing a program to be divided into 'threads' , many of which can be run at the same time. Thus not only can numerous programs run simultaneously, but one program can perform numerous tasks at the same time. The IBM OS/2 Warp includes easy access to networks via modem, support for Java applications and voice recognition technology.

<b>UNIX</b>	This operating system, designed by Bell laboratories in the USA for minicomputers, has been widely adopted by many corporate installations. From the very first, it was designed to be a multitasking system. It is written in C language. It has become an operating environment for software development, available for any type of machine, from IBM PS/2s to Macs to Cray supercomputers. UNIX is the most commonly used system for advanced CAD programs.
<b>Linux</b> (Linus Torvalds)	Protected under the GNU general public license, Linux is the open source, cooperatively-developed POSIX-based, multitasking operating system. The term **user interface** refers to the standard procedures the user follows to interact with a particular computer. A few years ago, the way in which users had access to a computer system was quite complex. They had to memorize and type a lot of commands just to see the content of a disk, to copy files or to respond to a single prompt, in fact, only experts used computers, so there was no need for a user-friendly interface. Now, however, computers are used by all kinds of people and as a result there is a growing emphasis on the user interface.

A good user interface is important because when you buy a program you want to use it easily. Moreover, a graphical user interface saves a lot of time: you don't need to memorize commands in order to execute an application; you only have to point and click so that its content appears on the screen.

Macintosh computers – with a user interface based on graphics and intuitive tools – were designed with a single clear aim: to facilitate interaction with the computer. Their interface is called WIMP: Window, Icon, Mouse and Pointer and software products for the Macintosh have been designed to take full advantage of its features using this interface. In addition the ROM chips of a Macintosh contain libraries that provide program developers with routines for generating windows, dialog boxes icons and pop-up menus. This ensures the creation of applications with a high level of consistency.

Today; the most innovative GUIs are the Macintosh, Microsoft Windows and IBM OS/2 Warp. These three platforms include similar features: a desktop with icons, windows and folders, a printer selector, a file finder, a control panel and various desk accessories. Double-clicking a folder opens a window which contains programs, documents or further nested folders. At any time within a folder, you can launch the desired program or document by double-clicking the icon, or you can drag it to another location.

The three platforms differ in other areas such as device installation, network connectivity or compatibility with application programs.

These interfaces have been .so successful because they are extremely easy to use. It is well known that computers running under an attractive interface stimulate users to be more creative and produce high quality results, which has a major impact on the general public.



***Word-processing facilities***

Writing letters, memos or reports are the ways most people use computers. They manipulate words and text on a screen – primarily to print at some later time and store for safe keeping. Computers alleviate much of the tedium associated with typing, proofing and manipulating words. Because computers can store and recall information so readily, documents need not be retyped from scratch just to make corrections or changes. The real strength of word processing lies in this ability to store, retrieve and change information. Typing is still necessary (at least, for now) to put the information into the computer initially, but once in, the need to retype only applies to new information.

Word processing is more than just typing, however. Features such as ***Search*** and ***Replace*** allow users to find a particular phrase or word no matter where it is in a body of text. This becomes more useful as the amount of text grows.

Word processors usually include different ways to view the text. Some include a view that displays the text with editor's marks that show hidden characters or commands (spaces, returns, paragraph endings, applied styles, etc). Many word processors include the ability to show exactly how the text will appear on paper when printed. This is called WYSIWYG (What You See Is What You Get, pronounced 'wizzy-wig'). WYSIWYG shows **bold**, *italic*, underline and other type style characteristics on the screen so that the user can clearly see what he or she is typing. Another feature is the correct display of different typefaces and **format** characteristics (margins, indents, super- and sub-scripted characters, etc). This allows the user to plan the document more accurately and reduces the frustration of printing something that doesn't look right.

Many word processors now have so many features that they approach the capabilities of **layout applications** for desktop publishing. They can import graphics, format multiple columns of text, run text around graphics, etc.

Two important features offered by word processors are automatic **hyphenation** and **mail merging**. Automatic **hyphenation** is the splitting of a word between lines so that the text will fit better on the page. The word processor constantly monitors words typed and when it reaches the end of a line, if a word is too long to fit, it checks that word in a hyphenation dictionary. This dictionary contains a list of words with the preferred places to split it. If one of these cases fits part of the word at the end of the line, the word processor splits the word, adds a hyphen at the end and places the rest on the next line. This happens extremely fast and gives text a more polished and professional look.

**Mail merge** applications are largely responsible for the explosion of 'personalized' mail. Form letters with designated spaces for names and addresses are stored as documents with links to lists of names and addresses of potential buyers or clients. By designating what information

goes into which blank space, a computer can process a huge amount of correspondence substituting the 'personal' information into a form letter. The final document appears to be typed specifically to the person addressed.

Many word processors can also generate tables of numbers or figures, sophisticated indexes and comprehensive tables of contents.

The ‘welcome’ screen that pops up when someone switches on a computer would not appear without software. Software refers to the sets of coded instructions – programs – and the data that they need. This is different from hardware, which is a computer’s circuitry, casing and the rest of its physical parts. Most people use software through a graphical user interface (GUI) with drop-down menus, windows, and a moveable pointer. The GUI acts as a visual arena where the user interacts with the computer.

The software that controls the computer’s basic functions is called its operating system (OS). It is the master software, controlling how all other running software uses the processing power of the CPU and the computer’s memory. It is kept in the RAM and run by the CPU whenever the computer is on. The OS also controls input and output. It interprets the meaning of the keys pressed on the keyboard and the clicks on the mouse, translating them into signals that programs can use.

Since the early 1980s, operating systems have communicated with their human users through a graphical user interface (GUI). Microsoft Windows is the most widely used OS series today – the GUI here belongs to Windows 7.

Computer users store data in blocks called files. Files are often grouped together into folders, or directories, to make finding them easier. Different types of files can be distinguished by the last few letters of their names – their ‘file extension’. Extensions are used by the OS to select relevant applications to open different files. A file that ends with ‘wav’ or ‘mp3’, for instance, is a type of audio file, while ‘bmp’, ‘jpg’, or ‘gif’ are extensions of different image files.


When users need to access information on the Internet, they use programs called web browsers that allow them to search or surf the web. When accessing a web page, the browser sends a request for the page and then displays the data it receives. This is the logo of Mozilla Firefox, a web browser second only to Internet Explorer in popularity. Firefox is an example of freeware – a type of software that can be used without paying a fee. Firefox is not the original name of the browser – it was previously called Phoenix and then Firebird, but both names had already been used for other software.



Many types of software have developed mainly for use in business. People use spreadsheet programs to store and analyze data, such as sales figures. Once a user enters figures, the program calculates statistics such as totals and averages, and displays the data in a whole range of charts. Students commonly use programs such as word processors and presentation software for their schoolwork.

Computers, especially those connected to the Internet, are vulnerable to a wide range of security threats, including viruses and worms. 

### *Programming languages*

Unfortunately, computers cannot understand ordinary spoken English or any other natural language. The only language they can understand directly is called **machine code**. This consists of the 1s and 0s (binary codes) that are processed by the CPU.

However, machine code as a means of communication is very difficult to write. For this reason, we use symbolic languages that are easier to understand. Then, by using a special program, these languages can be translated into machine code. For example, the so-called **assembly languages** use abbreviations such as ADD, SUB MPY to represent instructions. These mnemonic codes are like labels easily associated with the items to which they refer.

Basic languages, where the program is similar to the machine code version, are known as **low-level languages**. In these languages, each instruction is equivalent to a single machine code instruction, and the program is converted into machine code by a special program called an **assembler**. These languages are still quite complex and restricted to particular machines.



To make the programs easier to write and to overcome the problem of intercommunication between different types of machines, higher-level languages were designed such as BASIC, COBOL, FORTRAN or Pascal. These are all problem-oriented rather than machine-oriented. Programs written in one of these languages (known as **source programs**) are converted into a lower-level language by means of a **compiler** (generating the **object program**). On compilation, each statement in a **high-level language** is generally translated into many machine code instructions.

People communicate instructions to the computer in symbolic languages and the easier this communication can be made the wider the application of computers will be. Scientists are already working on Artificial Intelligence and the next generation of computers may be able to understand human languages.

***Computer viruses***

The Maltese Amoeba may sound like a cartoon character, but if it attacked your computer, you wouldn't be laughing. The Maltese Amoeba is a computer virus. It is a form of software which can 'infect' your system and destroy your data. Making computer viruses is only one type of computer crime. Others include hacking (changing data in a computer without permission) and pirating (illegally copying software programs).

Viruses are programs which are written deliberately to damage data. Viruses can hide themselves in a computer system. Some viruses are fairly harmless. They may **flash** a message on screen, such as 'Gotcha! Bet you don't know how I crept in'. The Yankee Doodle virus plays this American tune on the computer's small internal speaker every eight days at 5 p.m. Others have serious effects. They attach themselves to the operating system and can wipe out all your data or turn it into **gobbledegook**. When the Cascade virus attacks, all the letters in a file fall into a heap at the bottom of the screen. This looks spectacular but it's hard to see the funny side when it's your document.

Most viruses remain **dormant** until activated by something. For example, the Jerusalem B virus is activated every Friday the 13<sup>th</sup> and erases any file you try to load from your disk. The Michelangelo virus was programmed to become active on March 6th 1992, the 517<sup>th</sup> birthday of Michelangelo. It attacked computer systems throughout the world, turning data on hard disks into nonsense.

Viruses are most commonly passed via disks but they can also spread through bulletin boards, local area networks, and email attachments. The best form of treatment is prevention. Use an antivirus program to check a floppy before using it. Always download email attachments onto a floppy and check for viruses. If you do catch a virus, there are antivirus programs to hunt down and **eradicate** the virus. The problem is that around 150 new viruses appear every month and you must constantly update your antivirus package to deal with these new forms.



## INTERESTING FACTS

### 1. Read the text and say what it is about.

Computers exist to run programs. A program is a series of instructions that tells a computer what to do next. In a simple program, a task is broken down into its most basic steps. The computer doesn't understand what links each step and just follows the instructions. A more complex program is divided into sections called subroutines. Each one performs a smaller part of the program, can be used many times, and exchanges data with other subroutines. This makes the program smaller and easier to understand. Programmers write their programs in one of many specialized computer languages, which they call 'code'. Regardless of the programming language, a computer converts, or

compiles, the program into machine code – a string of numbers that microprocessors recognize. Some programmers write snippets of code and store them in libraries on the Internet. Others use these fragments to build their own programs easily, without having to start from scratch each time.

In 1801, the French inventor Joseph Marie Jacquard invented a loom that could weave finely patterned cloth automatically – and do it much more quickly than by hand. Although this loom was not a computer, people could program it using punch cards. These were long strips of cardboard filled with holes that corresponded to the threads making up each pattern. In the 1950s and 1960s, people used punch cards in a similar way to input the programs that ran on early computers.

In the 1840s, Lady Ada Lovelace, the daughter of the English poet Lord Byron, worked with Charles Babbage, the inventor of some early mechanical computers. She created a program on punch cards for one of Babbage's machines, the Analytical Engine. This complicated machine was never built and the program was not used. Nevertheless, Ada Lovelace is regarded as the first computer programmer. In 1979, the US military named a new programming language Ada in her honor.

In the 1980s, small robots – called turtles – were used to teach the type of very precise instructions needed in programming. The robots drew patterns on the floor according to their program and could make this spiral by following a few steps – distance equals one unit, move forward one unit, turn right, repeat steps 2 and 3, distance equals 2 units, and so on. Programs could apply the same technique on a screen to make a line graphic.

Programs need to be cleared of mistakes. However, bugs, or errors, still get through. As the year 2000 approached, experts found an error that came to be called the Millennium Bug. Old programs recorded a year as just two numbers – 1999 was 99, and the following year would be 00. So there was a possibility that the world's computers would record year 00 as 1900 not 2000, causing computers to stop working properly – or at all! Programmers worked hard to beat the bug by making computers record a year as four numbers. When 2000 rolled in, no major problems were found.

A badly designed program can cause a disaster. The European Space Agency uses Ariane 5 rockets to launch spacecraft. In 1996, an

Ariane 5 rocket exploded on its first test flight. The guidance program was written for an older rocket and did not work with the Ariane 5 rocket's new launch system. Spacecraft often run using old-fashioned computer systems, because engineers are confident their programs do the job well and making a new one is risky and expensive. NASA's Space Shuttles used a computer designed in the 1970s with less processing power than most mobile phones!
